#### ARTICLE IV

#### Povers

In furtherance of its purposes, the Association shall have all of the powers conferred upon associations not for profit by the statutes of the State of Colorsdo in effect from time to time, including all of the powers necessary or incidental thereto to parform the duties and exercise the rights and powers of the Association under the Constituent Documents which will include, but shall not be limited to, the following:

### Momberships

Membership in the Association shall consist of the following:

Upon the sale or transfer of a Townhouse in the Project by an Owner, that person's membership rhall be automatically transferred to the purchaser or transferree.

2. Declarant or its successors, designators or assigns shall be Members.

#### ARTICLE VII

#### Voting

The Association shall have two classes of voting membership.

CLASS A. All Owners shall be "Class A Hembers." Class A Hembers shall be entitled to one vote for each Townhouse in which they hold the interests required for membership. When more than one person holds such interest, the vote for such Townhouse in the Project shall be exercised by one of them designated by written instrument to be the sole voting Member, but in no event shall more than one vote be cast with respect to any such Townhouse in the Project. In the absence of such designation, the Board may designate such a sole voting Member.

CLASS B. The Class B Member shall be the Declarant. The Class B Member shall be entitled to those votes for each Townhouse in the Project in which it holds the interests required for membership, provided that the Class B membership shall be converted to Class A membership on the happening of either of the following events, whichever occurs earlier:

1. When the total votes (based upon all Townhouses in the Project owned, including Townhouses in hereinafter annexed property) outstanding in the Class A membership equal the total votes outstanding in the Class B membership, or
